- Each vendor is responsible for their own tables, chairs, etc., **electricity is provided but limited and not guaranteed;** however, vendors are responsible to provide their own extension cords.
- Canopy tents are welcomed, but vendors are responsible for tie downs, weights, etc.
- All food vendors require a current Health Permit & can be obtained at Weslaco City Hall
- All food vendors must follow food handler safety requirements, see page attached. If you fail inspection, you may not be able to sell on the day of the event.
- All vendors are required to have a current fire extinguisher during event.
- All vendors are required to have (1) hand sanitizer bottle available for public usage
- Vendor set up times is between 3:30 p.m. and 5:30p.m. no exceptions, all vehicles are to be moved out of vendor area no later than 5:30 p.m. (If a vendor fails to set up between times provided, present vendors will have a choice to move up to an empty vendor spot)
- I understand if I fail to abide to the rules and regulations, I may be prevented from participation in any future City of Weslaco and EDC-Weslaco events.
- Although Facemask are not mandatory, EDCW staff does encourage all vendors to wear one.
- **All vendors must enter between 4th and 5th street on the EAST SIDE.**

In addition, I understand fully that the \$25.00 fee is non refundable, in regards to elements out of the EDC-Weslaco's control.
